



Percentage of Telecom Revenue by Services: 2022



Telecom Subscribers by Services






Telecom Services Subscribers per 100 Inhabitants or Households






Fixed Broadband Subscribers -by Technologies






Percentage of Fixed Broadband Subscribers -by Advertised Downstream Speeds





Evolution of Mobile Market






Active Mobile Broadband Subscriptions

Proportion of Mobile Prepaid Card Subscribers





Average Revenue Per User (ARPU) of Mobile Services in December each year








Volume of Mobile and Fixed-Voice






Mobile Data Volume






SMS (Short Message Service) Volume and Revenue



Note: SMS contact tracing was implemented for Covid-19 from May 2021 to April 2022.




MMS (Multimedia Messaging Service) Volume and Revenue
