
Application process Flow on Establishment of an Academic or Experiment, Research and Development **Telecommunications Network**



Remark: 1. * To simplify the license renewal, the network operation license and the radio station license may be merged in the application and approval/issuance.

2. An application stating the reasons shall be presented to the commission one month prior to the expiration of the valid period.

Application Form for the Establishment and Operation of an Academic or Experiment, Research and Development Telecommunications Network (1)

In accordance with provisions set forth under Article 8 or Article 18 of the Administrative Regulations for the Establishment and Operation of a Telecommunications Network for Academic or Experiment, Research and Development Purposes, enclosed in the submittal are the application form, establishment proposal and other relevant specified documentation, by which to apply for the establishment and operation of a telecommunications network for academic or experiment research and development purposes; the applicant also consents to presenting the experimentation findings to the competent authority according to provisions set forth in Article 36 of this Regulation when the experimentation concludes; the competent authority may openly disclose the findings as regulated.
