The Examination Regulations for the License Renewal of Satellite Broadcasting and Foreign Satellite Broadcasting Businesses were promulgated on the 16th of July 2016, in accordance with the amendment made to the Satellite Broadcasting Act on the 6th of January 2016. Anyone who, before this amendment, had been transmitting programs or advertisements of a specific channel to the public audio and visual broadcasting platform via methods other than satellite, should apply for license

renewal as an Other Type Channel and Program Supply Business within six months prior to the expiration of its license.
